

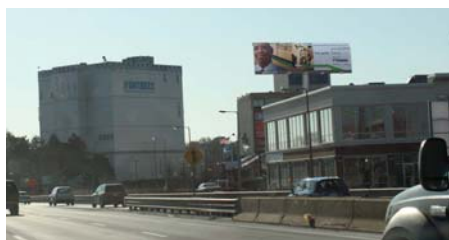

**IconGroupe Seeks Support
for Billboard on Boston
Street 1-93 Ramp**



IconGroupe representatives **Frank Podany, Drew Hoffman** and **Anne Kane** will be at this meeting to seek membership support for the construction of a billboard that would be located on the edge of the **South Bay Mall** between **Bickfords** and the new **Sleepys Mattress** building on the new building's property. Icon Groupe is changing their original proposal by reducing their live copy space from 20' x 60' to 14' x 48'. They are also proposing to reduce the height to 60' to 70' so that the sign would be under the height of the six story Holiday Inn Express.

**Should Resident Permit
Parking Be Expanded?**



Since 2006 resident permit parking has been posted and enforced on Buttonwood, Locust, Mayhew, Mount Vernon, Roseclair and Saint Margaret Streets.

The four hour enforcement period is from 10 a.m. to 2 p.m. Commuters from outside the neighborhood, who formerly used these streets as free T' parking, have now moved to **Greenhaldge, Harvest, Dorset, Bellflower, Howell** and **Washburn Streets**, all of which remain without resident permit parking. A group of neighbors from these streets are proposing that the resident permit program be expanded to these streets.
