**Mass. Ave. Sewer  
Separation Project**



The Director of Construction at **Boston Water & Sewer, Irene McSweeney**, and her team will update us on the Mass Ave. Sewer Separation project that is now concentrated on the side streets off Boston Street. The project involves separating the combined sewer system into sanitary sewer lines and storm water lines to reduce outflow of pollutants to the Harbor. Presentation details will include the timeline and map of affected streets and avenues.
